



**MEMORANDUM OF UNDERSTANDING
BETWEEN**

AND

NONOI COLLEGE, NAGAON, ASSAM, INDIA

Dr. B.K.B. College, Puranigudam, Nagaon, Assam, hereinafter referred to as "BKBC" and Nonoi College, Nono, Nagaon, Assam, hereinafter referred to as "NCN", hereinafter individually referred to as "the Party" and jointly referred to as "the Parties".

Acknowledging that –

1. BKBC is a Degree level provincialized educational institution, having its address as Puranigudam, Nagaon, Assam – 782141
2. NCN is a Degree level provincialized educational institution, having its address as Nonoi, Nagaon, Assam – 782101

DESIRING to – Support the cooperation between the Parties in Academic and Extension Activities,

PURSUANT to – the prevailing laws and regulations, policies and procedures that govern the educational institutes of Assam

HAVE REACHED the following understanding:

ARTICLE 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MoU) is to cooperate in academic and extension activities in areas of mutual interests.

ARTICLE 2

SCOPE OF COOPERATION

The Parties agree to implement cooperation programmes including but not limited to:

- (a) Faculty Support under Educational Institute Linkage Programmes
- (b) Academic support to the students
- (c) Extension activity support
- (d) Any other areas as mutually agreed upon by the Parties



ARTICLE 3

LOCATION OF ACTIVITIES

The Parties agree to implement the programmes stated in ARTICLE 2 at BKBC and NCN.

2. Any changes to the location of the programmes shall be mutually agreed upon by the Parties.

ARTICLE 4

FINANCIAL ARRANGEMENT

1. Any cooperation under this MoU is subject to the availability of funding sources and approval by relevant authorities.

2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangements.

ARTICLE 5

INTELLECTUAL PROPERTY RIGHTS

1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.

2. In case of specific arrangement, programmes or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

ARTICLE 6

AMENDMENT

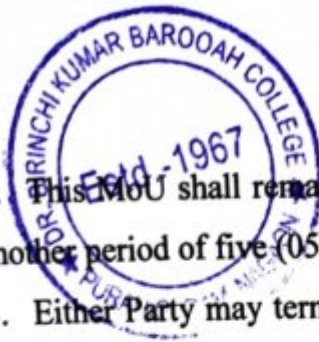
1. This MoU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MoU.

2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

ARTICLE 7

ENTRY INTO FORCE, DURATION AND TERMINATION

1. This MoU shall enter into force on the date of signing.



2. This MoU shall remain in force for a period of five (05) years and may be extended for another period of five (05) years by mutual consent of the Parties.

3. Either Party may terminate this MoU at any time by given written notification to the other Party on its intention to terminate this MoU, six (06) months prior to the date of the termination.

4. The termination of this MoU shall not affect the completion of any programmes or projects in progress and not completed at the time of termination.



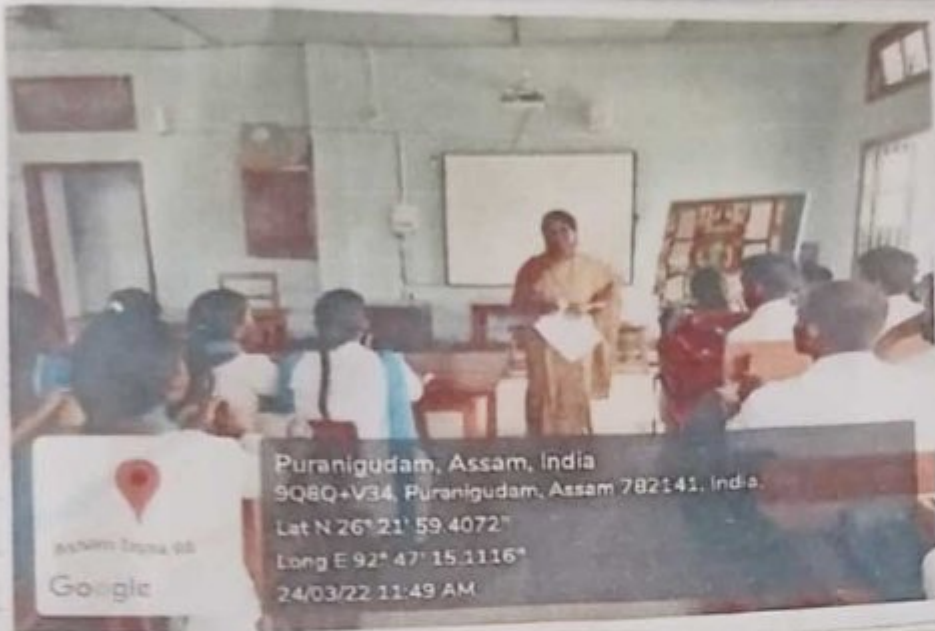

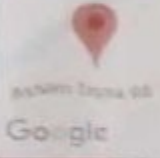

Memorandum of Understanding (MoU)
Between
Hatichong College, Nagaon
&
Nonoi College, Nagaon.

This Memorandum of Understanding (MoU) is come into force on **1st August, 2019** by and between Hatichong College, Nagaon and Nonoi College, Nagaon. Both the Colleges shall also be collectively referred to as the “Parties” or the “Institutions.” Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another. The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of both the Second Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the First Party. Both the parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.

Objectives of MoU:

- Joint research projects and publications, including work by the students of the partner institutions;
- Faculty and student exchange programmes based on reciprocity;
- Reciprocal placement of students in paid internships and co-ops, when possible;
- Joint conferences, workshops, Seminar, Webinar etc.

- Joint Games, Sports and cultural activities.
- Generate self-employment opportunities;
- Exchange on Best Practice;
- Arrange the placement of trained students;
- Team taught courses, including online courses; and
- Visits by faculty, professional staff, and students.

Both the parties anticipate that a number of these initiatives will occur during the period of this MOU.

Responsibilities of home institution for academic semester or academic year exchanges:

The home institution will:

- Register its own students for the duration of the exchange.
- Submit to the host institution the names and academic credentials of students who would like to participate in an exchange.
- Provide the host institution with names of courses that are essential to their own students' curricular plan.
- Advise its students about academic and cultural expectations at the host institution.
- Both the programme Coordinators should prepare Session-wise programme list to be implemented during the session.

Responsibilities of the host institution for academic semester or academic year exchanges:

The host institution will:

- Be responsible for admission decisions of students recommended by the home institution.

ACKNOWLEDGING that;

1. NC is a degree level Provincialized educational institution, having its address as Nonoi, Nagaon, Assam, India, 782101.
2. SC is a degree level Provincialized educational institution, having its address as, Hahsara Barali Gaon, Nagaon, Assam, India, 782140.

DESIRING to; support the cooperation between the Parties in education and research activities;

PURSUANT to the prevailing laws and regulations, policies and procedures applicable in the state of Assam and India;

HAVE REACHED the following understanding: -

**ARTICLE 1
OBJECTIVE OF COOPERATION**

2. SC appoints the Coordinator, IQAC, SC (hereinafter referred to as SC Rep).

ARTICLE 5
FINANCIAL ARRANGEMENT

1. Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangements.

ARTICLE 6
INTELLECTUAL PROPERTY RIGHTS

1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
2. In case of specific arrangement, programmes, activities or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

ARTICLE 7
CONFIDENTIALITY

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.

ARTICLE 8
LIMITATION OF PERSONAL ACTIVITIES

The Parties shall ensure that their personnel engaged in the activities under this MOU shall engage only in activities under the framework of this MOU with respect to laws and regulations in the state of Assam and the country of India.

ARTICLE 9
SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between Parties.

ARTICLE 10
AMENDMENT

1. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MOU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

ARTICLE 11
